Background

ENVIRONMENTAL Standards Scotland

- Brexit leads to loss of European Commission's oversight and EU Court of Justice's power to compel compliance and impose sanctions
- Withdrawal from the European Union (Continuity) (Scotland) Act 2021

- ESS established as a Non-Ministerial Office
- Independent of Scottish Ministers reports to Scottish Parliament
- New body to oversee public authorities including regulators

Functions

- To monitor & investigate <u>compliance</u> with environmental law and the <u>effectiveness</u> of environmental law and how it is implemented and applied
- To ensure public authorities' <u>compliance</u> with environmental law and to improve <u>effectiveness</u>
- Includes implementation of international obligations
- <u>Not</u> expected to deal with individual cases & not an appeals body
 - i.e. ESS may not take action on "a failure to comply with environmental law arising out of any decision taken by a public authority in the exercise of its regulatory functions in relation to a particular person or case (for example, a decision on an application for a licence or a decision on regulatory enforcement in a specific case)"

Scope of Remit

ENVIRONMENTAL Standards Scotland

• Continuity Act defines "environmental law" for ESS remit

44 Meaning of "environmental law" and "effectiveness of environmental law"

(1) In this Chapter, "environmental law" means any legislative provision to the extent that it—

(a) is mainly concerned with environmental protection, and

(b) is not concerned with an excluded matter.

(2) Excluded matters are—

- (a) disclosure of, or access to, information,
- (b) national defence or civil emergency,
- (c) finance or budgets.

Duties and Powers

ENVIRONMENTAL Standards Scotland

- Public authorities have a duty to cooperate with ESS
- Key Powers:
 - To monitor and investigate environmental issues (compliance/effectiveness)
 - Information Notices to obtain information from authorities
 - Compliance Notices issued to public authority(s)
 - Improvement Reports issued to Scottish Government & laid in Parliament
 - ✤ Apply for Judicial Review if issue is 'serious'


<u>BUT</u> – duty on public authorities & ESS to try to resolve issues informally wherever possible

Progress

- Chairman & 4 Board Members recruited and Interim CEO and 11 staff appointed
- Established as independent body on 1st October 2021
- Interim Strategic Plan published
- Representation form published
- Investigation/Enforcement procedures prepared
- First investigation commenced
- Stakeholder engagement under way

How will ESS operate?

- Interim Strategic Plan published on 1st October 2021
- Sets out ESS approach for period until final Strategy approved by Scottish Parliament
- Feedback welcome



ESS Principles


- We will <u>target our efforts and resources</u> where we can add most value focusing where our contribution is needed most or will make most difference.
- We will seek to resolve issues through agreement wherever possible having recourse to our formal powers where we judge it is necessary to deliver the outcome expected.
- We will be <u>evidence driven</u> seeking a wide range of inputs and expertise to inform our work and to support our decisions and advice.
- We will be <u>open and transparent</u> keeping people informed about the progress of our work and providing opportunities to input to and influence it.
- We will <u>seek opportunities to work in partnership</u> with others working closely with all relevant stakeholders to ensure that our collective efforts deliver benefits for environmental protection and enhancement.



Monitoring & Evaluating Environmental Performance & Change






- ESS will conduct its own independent analysis of data & research on Scotland's environment
- Aiming to bring together evidence to understand the causes & identify where there may be issues with compliance/ effectiveness
- Practical and outcome focused – serving the investigative needs of ESS
- Aim to publish a forward work programme of issues



Investigating the Most Important Environmental Concerns


- Investigation can be prompted by a representation to ESS or by our own monitoring
- Preliminary assessment, validation & prioritisation undertaken → investigation

Ensuring Compliance & Effectiveness



Raising a concern with ESS

- <u>Anyone</u> can raise a concern via a 'representation' form on our website
- ESS staff can help to focus the representation
- We will refer or signpost to an alternative course of remedy where appropriate
- Representation must be about <u>non-compliance</u> or <u>ineffectiveness</u> of environmental law
- Will normally expect:
 - Issue to have been raised with the public authority concerned first
 - > Clear identification of the area of law that the concern relates to
 - > Clear identification of why it's believed there is non-compliance or ineffectiveness
- We will update the person raising the representation once we have decided whether to investigate and will update them as the case progresses

ESS Investigation into Air Quality

ENVIRONMENTAL Standards Scotland

"An investigation into the Scottish Government's plans and approach to ensuring future compliance with legal limits on nitrogen oxide levels"

- European Court of Justice Judgement issued in March 2021
- 2010-2017 "systematic and persistent" failure to meet NO₂ limits
- Focus on Scottish Government & arrangements to secure compliance






Shaping the Future of ESS Standards Scotland

- ESS must prepare and consult on a final strategy setting out how it intends to carry out its role
- Final strategy must be submitted to Parliament for approval by 1st October 2022
- Detailed engagement on certain aspects of the strategy planned for February-May 2022
- Formal consultation on the strategy planned for May-August 2022
